## CONSTRUCT TAXIWAY LIMA AND TAXIWAY LIMA BRIDGE

**OWNER:** St. Clair County, Illinois, through the Public Building Commission, hereby gives notice that sealed bids will be received from bidders for the **Construct Taxiway Lima and Taxiway Lima Bridge** project at MidAmerica St. Louis Airport. St. Clair County promotes equal opportunities and encourages participation by Disadvantage Business Enterprise and Small Business firms.

**TIME AND PLACE OF BID OPENING:** Bids will be received until **2:00 p.m.** (local time) on the **1st day of February 2022** in the Department of Engineering and Planning, 9768 Airport Boulevard, Mascoutah, IL 62258, located at MidAmerica St. Louis Airport. Each bid must be submitted in accordance with all submission requirements set forth in the bidding documents. Facsimile submittals are not acceptable. **Late bids will not be accepted**. Questions must be directed in writing as detailed in the Instructions to Bidders.

**SCOPE OF WORK:** This project includes but is not limited to construction of new Taxiway Lima, including the Taxiway Lima Bridge, Construction of the extension of the Airside Service Road, drainage improvements, security system improvements, installation of new edge lights and other electrical improvements, installation of new perimeter fencing and gates, taxiway and roadway markings, seeding/sodding/mulching and other erosion control measures.

**BIDDERS QUALIFICATIONS:** Prospective bidders who desire to submit a bid as a prime contractor must be prequalified with the Illinois Department of Transportation.

The prime contractor and subcontractors performing work on the following work items shall also be prequalified with the Illinois Department of Transportation: concrete paving, bituminous paving, aggregate base, electrical pay items and bridge construction.

**BID GUARANTY:** No bid will be considered unless accompanied by a certified check or cashier's check on any bank or trust company insured by the Federal Deposit Insurance Corporation, payable to the OWNER, for not less than five (5) percent of the total amount of the Bid, or by a Bid Bond secured by an approved surety or sureties, payable to the OWNER, for not less than five (5) percent of the total amount of the Bid in accordance with the Instructions to Bidders. The bid deposit shall be separate from the bid quaranty.

PRE-BID CONFERENCE: A non-mandatory pre-bid conference for this project will be held on January 12, 2022 at 10:00am at the at MidAmerica St. Louis Airport Terminal Building.

**CONTRACT TIME:** The owner has established a contract completion date of July 1, 2023. All project work shall be substantially completed within the stated timeframe. This project is subject to liquidated damages as prescribed in the project manual.

**BONDING REQUIREMENTS:** The successful bidder will be required to furnish separate performance and payment bonds each in an amount equal to 100% of the contract price at the time of contract execution.

**BID WITHDRAWAL:** No Bid shall be withdrawn for a period of 45 days after the scheduled opening of the Bids without the consent of OWNER.

**BID REJECTION:** OWNER reserves the right to reject any and all Bids, waive any informalities in Bidding, or to accept the Bid or Bids, which best serves the interests of OWNER.

**LEGAL PROVISIONS:** CONTRACTORS and Subcontractors shall conform to the "Public Works Preference" Act (30 ILCS 560/1, et. seq.)

**WAGE REQUIREMENTS:** CONTRACTORS shall be required to pay not less than the highest prevailing wage rates on the project as established by the State of Illinois, Department of Labor. Project Wage Rates can be found in Section 3, Part C.

**STATE PROVISIONS:** This project is subject to State Provisions, statutes, and regulations as presented in Section 3, Part A, State Provisions.

**LOCAL PROVISIONS:** This project is subject to certain local provisions, statutes and regulations outlined and presented in greater detail in Section 3, Part B, Local Provisions:

<u>Additional Provisions:</u> Modification to the project documents may only be made by written addendum by the Owner or Owner's authorized Representative.

The proposal must be made on forms provided within the electronic version of the project manual. The Proposal Form must be printed and submitted as part of the contractor's bid. Bidders must supply all required information prior to bid deadline indicated.
