NOTICE TO BIDDERS**

MidAmerica St. Louis Airport  
County of St. Clair, Illinois  
ACCESS IMPROVEMENTS AIRPORT BOULEVARD  
SOLICITATION NO. 2022-13

**OWNER:** St. Clair County, Illinois, through the Public Building Commission, hereby gives notice that sealed bids will be received for the construction of new signals at the intersection of IL Route 4 and Airport Boulevard. Work at the intersection also includes pavement marking, signs, lighting, closed circuit television dome camera, cellular modem and other miscellaneous items. The proposed improvement also includes the construction of fiber optic interconnect cable and conduit from approximately 2,400' south of Airport Boulevard north to the I-64 eastbound exit ramp. The project begins on IL Route 4 approximately 2,400' south of Airport Blvd. and continues north to the intersection of IL Route 4 with the I-64 exit ramp, for a total distance of 4,673.24 feet (0.885 miles) in St. Clair County. Such work is to be administered as an IDOT Access Permit, Permit No. 8-33386, and tied to all Access Permit requirements and required IDOT approvals concerning work on IDOT ROW. St. Clair County promotes equal opportunities and encourages participation by Disadvantaged Business Enterprise and Small Business firms.

**TIME AND PLACE OF BID OPENING:** Bids will be received until **2:30 p.m.** (local time) on the **7<sup>th</sup> day of June 2022** in the Department of Engineering and Planning, 9768 Airport Boulevard, Mascoutah, IL 62258, located at MidAmerica St. Louis Airport. Each bid must be submitted in accordance with all submission requirements set forth in the bidding documents. Facsimile submittals are not acceptable. **Late proposals will not be accepted.** Questions must be directed in writing as detailed in the Instructions to Bidders. Bids will be opened virtually. Instructions to access the virtual bid opening will be provided to the bidder once the bid documents have been requested.

**SCOPE OF WORK:** The proposed work includes the construction of new signals at the intersection of IL Route 4 and Airport Boulevard. Work at the intersection also includes pavement markings, signs, lighting, closed circuit television dome camera, cellular modem and other miscellaneous items. The proposed improvement also includes the construction of fiber optic interconnect cable and conduit from a point 2,400' south of Airport Boulevard north to the I-64 eastbound exit ramp.

**BIDDING DOCUMENTS:** Bidders may request the bid documents from the Airport Department of Engineering & Planning by e-mail (alice.tejada@flymidamerica.com). The bid documents and subsequent addenda (should there be any) will be distributed exclusively via e-mail to all plan holders. Bid documents will not be shipped.

**BIDDERS QUALIFICATIONS:** Prospective bidders who desire to submit a bid as a prime contractor must be prequalified with the Illinois Department of Transportation.

The prime contractor and subcontractors performing work on the following work items shall also be prequalified with the Illinois Department of Transportation: concrete paving, earthwork,, aggregate base, electrical pay items and .

**BID GUARANTY:** No bid will be considered unless accompanied by a certified check or cashier's check on any bank or trust company insured by the Federal Deposit Insurance Corporation, payable to the OWNER, for not less than five (5) percent of the total amount of the Bid, or by a Bid Bond secured by an approved surety or sureties, payable to the OWNER, for not less than five (5) percent of the total amount of the Bid in accordance with the Instructions to Bidders. The bid deposit shall be separate from the bid guaranty.

**PRE-BID CONFERENCE:** A pre-bid virtual conference will be held virtually prior to the Bid opening on **May 20, 2022 at 11:00 a.m.** to familiarize Bidders with the Project. A link to the conference will be provided to the bidder once the bid documents have been requested.

**CONTRACT TIME:** The owner has established a completion date of **December 15, 2022**. All project work shall be completed prior to this date. This project is subject to liquidated damages as prescribed in the project manual.

**BONDING REQUIREMENTS:** The successful Bidder will be required to furnish separate performance and payment bonds each in an amount equal to 100% of the contract price at the time of contract execution. The Bidder must provide an Highway Permit bond in the amount of \$475,000 to IDOT (see Appendix B).

**BID REJECTION:** OWNER reserves the right to reject any and all Bids, waive any informalities in Bidding, or to accept the Bid or Bids, which best serves the interests of OWNER.

**BID WITHDRAWAL:** No Bid shall be withdrawn for a period of 45 days after the scheduled opening of the Bids without the consent of OWNER.

**LEGAL PROVISIONS:** CONTRACTORS and Subcontractors shall conform to the "Public Works Preference" Act (30 ILCS 560/1, et. Seq)

**STATE WAGE REQUIREMENTS:** CONTRACTORS shall be required to pay not less than the prevailing wage rates on the project as established by the State of Illinois, Department of Labor.

**STATE PROVISIONS:** This project is subject to the State Provisions, statutes and regulations as presented Section 3, Part A, State Provisions.

**LOCAL PROVISIONS:** This project is subject to certain local provisions, statutes and regulations outlined and presented in greater detail in Section 3, Part B, Local Provisions.

**Additional Provisions:** Modification to the project documents may only be made by written addendum by the Owner or Owner's authorized Representative.

**The bid must be made on forms provided within the electronic version of the project manual. The Bid Form must be printed and submitted as part of the contractor's bid. Bidders must supply all required information prior to bid deadline indicated.**
