OWNER: St. Clair County, Illinois, through the Public Building Commission, hereby gives notice that sealed bids will be received from qualified vendors for the following:

Schedule I - Rubber Removal from Runway 14L 32R

Schedule II - Restriping Runway 14L/32R and Associated Taxiways

TIME AND PLACE OF BID OPENING: Bids will be received until 2:30 p.m. (local time) on August 15, 2022 in the Department of Engineering and Planning, 9768 Airport Boulevard, Mascoutah, IL 62258, at MidAmerica St. Louis Airport. Each bid must be submitted in accordance with all submission requirements set forth in the bidding documents. Facsimile submittals are not acceptable. **Late proposals will not be accepted.** Questions must be directed in writing as detailed in the Instructions to Bidders.

BIDDING DOCUMENTS: Bid documents will be available at no cost from the Airport Department of Engineering and Planning by e-mail (alice.tejada@flymidamerica.com). Bid documents will not be shipped. The bid documents will also be on file for inspection at the Southern Illinois Builder's Association (SIBA), 1468 Green Mount Road, O'Fallon, IL 62269. (618) 624-9065.

BIDDER'S QUALIFICATIONS: Contractor's Qualifications Statements, for the current year shall be on file with the OWNER or shall be filed with the Contractor's Bid.

LEGAL PROVISIONS: CONTRACTORS and Subcontractors shall conform to the "Public Works Preference" Act (30 ICLS 570/1, et. Seq.)

WAGE RATES: CONTRACTORS shall be required to pay not less than the prevailing wage rates on the project as established by the State of Illinois, Department of Labor, St. Clair County.

BID SECURITY: Guarantee will be required with each bid as a certified check on a solvent bank or a Bid Bond in the amount of five (5) % of the total amount of the bid, made payable to the Owner.

PRE-BID CONFERENCE: A pre-bid conference will be held on July 28, 2022 at 1:00 PM (local time) in the Airport Passenger Terminal, 9656 Air Terminal Dr, Mascoutah, IL 62258 to familiarize Bidders with project. A virtual component will also be available, information provided upon request.

BID REJECTION: Owner reserves the right to reject any and all Bids, waive any information in Bidding, or to accept the Bid or Bids which best serves the interest of OWNER.

BID WITHDRAWAL: No bid shall be withdrawn for a period of 45 days after the scheduled opening of the Bids without the consent of OWNER.
