OWNER: St. Clair County, Illinois, through the Public Building Commission, hereby gives notice that sealed bids will be received from qualified vendors for furnishing of the following equipment: **Aircraft Pushback**. St. Clair County promotes equal opportunities and encourages participation by Disadvantage Business Enterprise and Small Business firms.

TIME AND PLACE OF BID OPENING: Bids will be received until 10:00 a.m. (local time) on April 24, 2023, in the Department of Engineering and Planning, 9656 Air Terminal Drive, Mascoutah, IL 62258, located at MidAmerica St. Louis Airport. Each bid must be submitted in accordance with all submission requirements set forth in the bidding documents. **Late proposals will not be accepted.** Questions must be directed in writing as detailed in the Instructions to Bidders.

PRE-BID CONFERENCE: A pre-bid conference will not be held for this project.

BID SECURITY: Bid Security in the amount of not less that 5% of the Bid shall accompany each Bid in accordance with the Instructions to Bidders.

BIDDING DOCUMENTS: Bidders may request the bid documents from the Airport Department of Engineering & Planning by e-mail (alice.tejada@flymidamerica.com). The bid documents and subsequent addenda (should there be any) will be distributed exclusively via e-mail. Bid documents will not be shipped.

QUESTIONS: Questions regarding bids shall be directed to Contract Administrator, Alice Tejada, by email at alice.tejada@flymidamerica.com. Deadline for questions is 2:30 p.m., April 17, 2023.

CONTRACT SECURITY: The Bidder to whom a Contract is awarded shall be required to furnish both a Performance Bond and Payment Bond for 100% of the Contract Price for each of the above Bonds, in accordance with the requirements of the Contract Documents.

BID REJECTION: OWNER reserves the right to reject any and all Bids, waive any informalities in Bidding, or to accept the Bid or Bids, which best serves the interests of OWNER.

LEGAL PROVISIONS: CONTRACTORS and Subcontractors shall conform to the "Public Works Preference" Act (30 ILCS 570/1, et. seq.)

WAGE RATES: CONTRACTORS shall be required to pay not less than the prevailing wage rates on the project as established by St. Clair County, State of Illinois, Department of Labor.

BID WITHDRAWAL: No Bid shall be withdrawn for a period of 45 days after the scheduled opening of the Bids without the consent of OWNER.
