**SCOPE OF WORK:** This project includes but is not limited to construction of new Terminal Apron Expansion, drainage improvements, expansion of the existing glycol system, installation of new edge lights and apron lighting and other electrical improvements, apron and roadway markings, seeding/sodding/mulching and other erosion control measures.
